

Charles Llewellyn Foster, 24, of Hawthorne, Nevada, passed away on Sunday, September 29, 2019; at Renown Hospital in Reno, Nevada, after a 5-year long battle against cancer. He was survived by his wife Renee Christine Foster of Windsor, Colorado.

He was born on November 4, 1994, in Reno, Nevada, at Renown Hospital (formerly Washoe Medical Center in 1994). He was the oldest of seven brothers-and preceded in death by a sister, Katrina Foster, January 7, 1998.

He graduated high school in Loveland, Colorado and, then attended college at Front Range Community College for Computer Programming. He was an Assistant Meat Manager at King Soopers

Help Stop the Spread of Aquatic Hitchhikers...Clean, Drain. Aquatic Invasive Species (AIS) means any species not already native to the waters of the Pyramid Lake Paiute Reservation whose introduction those waters is likely to cause economic or environmental harm, or harm to human health. Aquatic Invasive Species pose a serious threat to the waters to the Truckee River-Pyramid Lake Region, and could have a disastrous impact on the ecology, infrastructure, recreation and economy of the Tribe. AIS threatens the health of our fisheries and aquatic ecosystem.





All watercraft, fishing equipment, and recreational gear that touch the water can pick up AIS. AIS are highly adaptable and can tolerate a wide range of environmental conditions. Once established, AIS are extremely difficult and costly to control or eradicate. Remove (Clean) all plant and animal material, mud and debris from the watercraft, trailer and boat equipment (anchors, buoys, etc.) Pull all plugs and Drain all residual water from inside the vessel including compartments, live-wells, ballast tanks, bilge areas, freshwater coolingsystems, lower outboard units, buckets, etc. Allow proper time for the vessel and boat equipment to completed Dry. Any standing water or wet gear has the potential to harbor AIS.

## **Burn Permits**

Burn Permits are available from October 1st through May 31st. Burning outside of the designated burn season poses a wildfire threat.

Agricultural Burning: AGRICULTURAL LANDS DO NOT REQUIRE A BURN PERMIT A person may conduct agricultural burns in fields, piles, ditch banks, fence rows for purposes such as weed control, disease and pest prevention, or site preparation. This does not include burning of household waste or prohibited materials.

#### **INSTRUCTIONS TO PERMITTEE:**

**Issuance of permit does NOT relieve the** Permittee of:

- all Open Burning Regulations as stated in Ordinance, No. 52-02-090- Open Burning.
- Their responsibility for any damage the fires may cause to other parties or their property. Good judgement should be used when burning even though a permit has been obtained.

**PLPT** Solid Waste Ordinance NO. 52-02-090- OPEN BURNING

- a. It is a violation of this Ordinance to dispose of solid waste by burning in open air, unless the Pyramid Lake Utility Board grants a variance. A Variance may be issued only for the disposal of leaves, weeds, and tree limbs and branches not more than 10 feet long during the approved burning months of the year. A permit must be obtained after the variance is granted.
  - Burning barrels are prohibited.
- Residential permits for open burning will be allowed and required for the burning of weeds, old lumber and yard waste at all residences within the reservation boundaries. There shall be no open burning during non- permitted months.

Notices will be posted when fire conditions exist. Non-burn months will be designated and posted when fire conditions exist. Open burning for the purpose of garbage disposal by any person is not allowed on the res-Their responsibility for complying with ervation, and shall subject the offender to civil and/or criminal misdemeanor liability. the Pyramid Lake Paiute Tribe Solid Waste The Tribal Fire and Police Departments shall be notified prior to any burning so they are aware and capable of responding to all controlled burns.

> Bon-fires more than 4 feet in diameter and 5 feet high will require a special burn permit issued by the Pyramid Lake Utility Board.

# This is for the upcoming 2019 Fourth Quarter Minor's Distribution Deadline:

### **FACT SHEET FOR MINOR'S DISTRIBUTION**

- 1. Funds will be received at least 2-3 months after deadline.

  Please plan accordingly.
- 2. All Minors' Applications are processed at the same time turning in a form earlier than the deadline doesn't ensure a faster result.
- 3. The whole process goes from receiving and verifying your information with our PLPT Enrollment office, which includes verifying Enrollment numbers, social security numbers and updated addresses. The paperwork is then submitted immediately to the Trust Company, which is then processed there for at <u>least a month</u>. The Trust Company then submits their completed forms to the Bank, and after verification with the bank, your money will THEN be distributed this sometimes takes up to 2-3 MONTHS. Please plan accordingly, and expect that your money will arrive 2-3 MONTHS after the Quarter Deadline.
- 4. The Trust company will contact the PLPT office for more information according to their standards your contact information needs to be legible just in case we need to reach you. If you can't be reached, your form will be held until you contact us.




### Minor's Distribution Information:

If you are age 18 or more by December 31, 2019, then you are eligible to receive your payment from the Minors Trust upon completion of distribution paperwork. Forms cannot be turned in early for "early processing", as all Minors' forms are processed quarterly, at the same time. Please make sure that your mailing address is up to date with the Enrollment office, that you include bank verification (including routing and account numbers, or a voided check – do NOT include a deposit ticket, as this does not include the necessary information), a clear copy of your picture ID included, and the second page marked and signed. The tax information brackets on top of the second page MUST be completed, or this will cause a delay in your payment. Please include CLEAR and LEGIBLE contact information in case you need to be reached!

If your forms are not turned into the Pyramid Lake Paiute Tribe until after the quarter ends, then your form will be held until the next quarter. Minors who have an account in the Minors Trust but are not able to return their forms timely will have up to six years to complete their forms and claim their economic stimulus payment. The six year deadline starts on your 18th birthday.

This is a reminder that the deadline for you to submit your forms for this 4th quarter of 2019 is on the last Tuesday of December 31, 2019. Forms are available in the Enrollment Office and online at: http://plpt.nsn.us/

driguez, visited Northern Nevada and the Pyramid treatment for tribes. Lake Paiute Tribe's Reservation on October 10th. In his meeting with the Pyramid Lake Paiute Tribe, Rodriguez was happy to learn that its Wadsworth Community Building will be an early caucus site, the only of its kind on a reservation in Nevada. This kind of early caucus access will ensure that Native communities have a voice and are represented when selecting the Democratic Party's nominee. Rodriguez also spoke about the issues affecting Nevada's indigenous communities the most: health care, child care, public lands, water allocation, and more. Too many of the issues facing Native communities are due to the United States' failure to meet its obligations with them. Rodriguez's visit and conversation came days before Kamala Harris released her plan to honor tribal sovereignty and lift up Native American communities.

As president, Kamala Harris will honor the United States' historic government-to-government relationship with Tribal Nations and invest in Native American communities to secure lasting prosperity. Harris will honor tribal sovereignty and will restore 500,000 acres of land for federally recognized Indian tribes. She will also work to rectify the environmental injustices Native communities have faced. Her Climate Equity Act ensures that Indigenous people are given a seat at the table, and that Indigenous communities give free, prior, and informed consent before projects that may affect them or their territory go forward.

Harris also knows that our tribal communities face unique health challenges. At Pyramid Lake, Rodriguez talked about how some health clinics in the reservation had to close during the government shutdown. Harris believes there should be more access to health care for tribes, not less, and will invest in telehealth

Harris' plan also calls for protecting Native women and children. As president, she will ensure there are up -to-date crime databases and coordination between law enforcement agencies to prosecute crimes, and will restore tribal jurisdiction to better protect Native women and children.

Her plan is a holistic approach to improving the quality of life and resources inside reservations by supporting the sovereignty, prosperity, health, education, safety, and civil rights of Native communities. Read more at https://kamalaharris.org/native-americans/.
