RESOLUTION OF THE TRIBAL COUNCIL

OF THE PYRAMID LAKE PAIUTE TRIBE

NIXON, NEVADA

WHEREAS, the Pyramid Lake Paiute Tribe, is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act, (25 U.S.C. 476) and is Federally recognized by the United States Government through the Secretary of the Interior to negotiate with the Bureau of Indian Affairs, Western Nevada agency; and

WHEREAS, the Bureau of Indian Affairs , Western Nevada Agency participated along with the Pyramid Lake Paiute Tribe with the Interagency Burned Area Emergency Response Team to develop The Burned Area Emergency Response Plan to revegetate, restore, and stabilize the Perry Fire area on the Pyramid Lake Reservation which are on Indian Trust lands; and

WHEREAS, the Burned Area Emergency Response Plan includes Treatments and funding to be completed by September 30, 2021; and

WHEREAS, the proposal being submitted is consistent with planning and development efforts towards other restoring the Tribal natural resources on the Pyramid Lake Indian Reservation for the betterment of the Tribe and its members.

WHEREAS. the Pyramid Lake Tribal Council hereby requests a 638 contract for the Burned Area Emergency Response Plan for the 2018 Perry Fire that the Pyramid Lake Paiute Tribal council approves, supports, and authorizes the Plan submittal to the Bureau of Indian Affairs Western Nevada Agency for Tribal funding.


