Coordinated Tribal Assistance Solicitation (CTAS FY 2018 – DOJ-2018-5410)

RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE INDIAN RESERVATION NIXON, NV

WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. 476) and is Federally recognized by the United States Government through the Secretary of the interior to negotiate with federal, state and local governments; and

WHEREAS, the U.S. Department of Justice, Office of Community Oriented Policing Services, Bureau of Justice Assistance, Office of Violence Against Women, Office for Victims of Crime and Office of Juvenile Justice and Delinquency have Consolidated its application process into one to improve and enhance public safety and victim services in Tribal communities and is accepting applications for funding under the FY 2018 Coordinated Tribal Assistance (CTAS), due March 20, 2018; and

WHEREAS, Directors with Pyramid Lake Paiute Tribe's Law Enforcement, Courts and Victim Services have collaborated in planning for 2018 CTAS funding for the purpose of ensuring the safety of all tribal members and have identified common problems and strategies to address them including greater coordination among agencies; and

WHEREAS, these Departments, entrusted with enhancing public safety and victim services will apply for 2018 CTAS funding under the following five Purpose Areas:

Purpose Area #1 – Public Safety and Community Policing. Tribal Law Enforcement will apply for up to \$600,000 to enhance community policing strategies; hiring of two police officers to enhance Tribal Law Enforcement's capacity to prevent, solve and control crime. Patrol vehicles which will allow tribal law enforcement to patrol and work to prevent crime on the Pyramid Lake Paiute Reservation.

Purpose Area #2 – Comprehensive Tribal Justice Systems Strategic Planning. Contracts and Grants will apply for up to \$150,000 to engage in comprehensive justice system-wide strategic planning to improve tribal justice and safety including community wellness and capacity to prevent crime, including activities outlined in the Tribal Law and Order Act (TLOA), such as strategic planning and

the development of a Tribal Action Plan (TAP).

Purpose Area #5 – Violence Against Women Tribal Governments Program.

Victim Services will apply for up to \$900,000 to strengthen the tribal criminal justice system's ability respond to crimes of violence against Indian women; to expand and improve services to support victims of domestic violence, dating violence, sexual assault, sex trafficking, and stalking and to victims of other severe forms of trafficking in persons who have also experienced domestic violence, sexual assault, dating violence, or stalking.

Purpose Area #7 – Comprehensive Tribal Victim Assistance Program. Victim Services will apply for up to \$450,000 to develop, enhance, and sustain a comprehensive victim assistance program that (1) provides a coordinated collaborative multidisciplinary response to victims of crime, their families, and the community and (2) provides trauma-informed, culturally competent holistic services to all identifiable victims of crime, their families, and the community.


Purpose Area #9 – Tribal Youth Program. Tribal Recreation will apply for up to \$400,000 to support and enhance tribal efforts to prevent and reduce juvenile delinquency and strengthen a fair and beneficial juvenile justice system response for Pyramid Lake tribal youth.

NOW THEREFORE BE IT RESOLVED, that the Pyramid Lake Paiute Tribal Council hereby approves and supports the submittal of the Tribe's application under the FY 2018 Coordinated Tribal Assistance Solicitation (CTAS FY 2018 – DOJ – 2018 - 5410).

BE IT FURTHER RESOLVED that the Tribal Chairman or his designee is hereby authorized to negotiate and sign all grant awards and other future administrative documents necessary for project awards and implementation.

CERTIFICATION

It is hereby certified that the foregoing resolution of the Pyramid Lake Paiute Tribal Council, governing body of the Pyramid Lake Paiute Tribe, composed of ten members, of whom **ten (10)** constituting a quorum were present at a meeting duly held on the **19th** day of **March**, 2018, was adopted by the affirmative vote of **eight (8)** FOR and **zero (0)** AGAINST, with **one (1)** ABSTENTIONS; pursuant to the authority contained in the Constitution and By-Laws of the Pyramid Lake Paiute Tribe.
