RESOLUTION OF THE PYRAMID LAKE PAIUTE TRIBE OF THE PYRAMID LAKE INDIAN RESERVATION NIXON, NEVADA

WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act of 1934 (25 U.S.C. §476), and is Federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and,

WHEREAS, under Article II of the Pyramid Lake Paiute Tribe's Constitution and By-Laws, the Tribal Council has the power to propose ordinances governing the membership and adoption of members by the Tribe, provided that no existing property rights are affected; and,

WHEREAS, Ordinance I, Ordinance II, Ordinance 1-89, Ordinance III and Ordinance III (First Revision) have been adopted by the Pyramid Lake Paiute Tribal Council to govern membership in the Pyramid Lake Paiute Tribe of Nevada.


