RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

A resolution authorizing the submittal of a proposal or proposals with the Nevada Department of Transportation for grants through the US DOT Federal Transit Administration (FTA), as authorized under Federal transit Law and funds available from the Nevada Public Transportation Grant Program and executing a contract with the Nevada Department of Transportation upon grant proposal acceptance.

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the Article VI, Section 1 of the Constitution and By-Laws of the Tribe,
- **WHEREAS,** the Director of the Nevada Department of Transportation is authorized to make grants for a public transportation program;
- WHEREAS, the contract for financial assistance will impose certain obligations upon the Pyramid Lake Paiute Tribal Transit, including the provision by it of the local share of the project costs in the program;
- WHEREAS, it is required by the U.S. Department of Transportation in accordance with the provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of an application for assistance, that the Pyramid Lake Paiute Tribal Transit give an assurance that it will comply with Title VI of the Civil Rights Act of 1964 and the U.S. Department of Transportation requirements thereunder; and
- whereas, it is the goal of the Pyramid Lake Paiute Tribal Transit that disadvantaged business enterprise to be used to the fullest extent possible in connection with this/these project(s), and that definite procedures shall be established and administered to ensure that disadvantaged businesses shall have the maximum construction contracts, supplies, equipment contracts, or consultant and other services.

NOW, THEREFORE BE IT RESOLVED: the Pyramid Lake Paiute Tribal Council is authorized to execute and submit an application of behalf of the Pyramid Lake Paiute Tribal Transit with the Nevada Department of Transportation to aid in the financing of capital and operating assistance projects and the Nevada Public Transportation Grant Program. The Pyramid Lake Paiute Tribal Council is authorized to execute and file with such application and assurance or any other document required by the U.S. Department of Transportation effectuating the purposes of Title VI of the Civil Rights Act of 1964. The Pyramid Lake Paiute Tribal Council is authorized to furnish such additional information as the Nevada Department of Transportation may require in connection with the application for the program of projects submitted to FTA. The Pyramid Lake Paiute Tribal Council is authorized to set forth and execute affirmative disadvantaged business policies in connection to any procurement made as part of the project. The Pyramid Lake Paiute Tribal Council is authorized to execute grant agreements on behalf of the Pyramid Lake Paiute Tribal Transit with the Nevada Department of Transportation for aid in the financing of operating and capital assistance projects.
