## **RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA**

**WHEREAS**, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. Section § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and

**WHEREAS**, The Pyramid Lake Paiute Tribe currently receives annual funding (Tribal Shares) under the Tribal Transportation Program (TTP) for Tribal Transportation projects; and

**WHEREAS**, 2% planning funds and Construction Funds in the Tribal Shares can be used to fund Tribal Transportation Planning Projects; and


**WHEREAS**, The Pyramid Lake Paiute Tribe has an existing Tribal Transportation Improvement Program (TTIP), which identifies previously approved projects, for the five year period beginning year 2017 and ending year 2021;

**WHEREAS**, The Pyramid Lake Paiute Tribe desires to update our current Tribal Transportation Improvement Program (TTIP) with the addition of the Tribal Transit Facility Project and the Wadsworth Complete Streets Project; and

**NOW, THEREFORE BE IT RESOLVED**, That the Pyramid Lake Paiute Tribal Council hereby requests BIA Transportation to add the Tribal Transit Facility Project and the Wadsworth Complete Streets Projects to the updated TTIP for the five year period beginning in year 2018 and ending in year 2022 projects as identified in the Tribal Transportation Program spreadsheet, hereby attached to this resolution:
