RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. Section § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and,
- WHEREAS, the governing body of the Pyramid Lake Paiute Tribe of Nevada, Tribal Council is organized under the provisions of the said Indian Reorganization Act of June 18, 1934 (48 Stat.98), is responsible for the promotion of cultural, economic and social welfare of its tribal members; and,
- WHEREAS, Tribal members need a large community building to reconnect with our cultural identity and improve quality of life through pow-wows, sports tournaments, craft fairs and funerals,
- **WHEREAS**, Tribal members need a large community building to promote the health and fitness of youth, adults and elders to reduce the rates of diabetes, heart disease and obesity,
- **WHEREAS,** Tribal members need a large community building to provide emergency shelter in times of disaster including earthquakes, floods and fires,
- WHEREAS, The Tribal Council made the Wadsworth gym project the number one priority for the next phase of the Wadsworth Community development project through a motion at the September 16, 2011 meeting,
- WHEREAS, The proposed project will serve the entire population of the Pyramid Lake Paiute Indian Reservation and surrounding communities,
- WHEREAS, Phase I, new Wadsworth Community Center and parking lot, was completed in 2015 and Phase II of the project is the multi-purpose cultural building/gym,
- WHEREAS, The Wadsworth Gym Project Planning committee is made up of volunteer community members who have been working on phase II since 2011, to plan a large multi-purpose Cultural building/gym project, to meet the above stated needs,
- WHEREAS, The Pyramid Lake Paiute Tribe has accepted \$92,750.00 from the BIA for right of way Compensation on the Wadsworth Bypass Road, per resolution #PL 51-18 dated May 4, 2018,

NOW, THEREFORE BE IT RESOLVED that the Pyramid Lake Paiute Tribal Council hereby approves and authorizes to the use the \$92,750.00 to complete Architect's Design for the Wadsworth multi-cultural building/gym.

BE IT FINALLY RESOLVED that the Pyramid Lake Paiute Council authorizes the Chairman, Vice Chairman or their designee to execute any and all documents necessary to facilitate the intent of this resolution.
