RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior for programs and services provided by the Bureau of Indian Affairs; and
- WHEREAS, the Pyramid Lake Paiute Tribal Council ("Tribal Council"), the governing body of the Pyramid Lake Paiute Tribe, by Ordinance No. X, adopted on February 7, 1963, chartered a public corporation known as the Pyramid Lake Housing Authority ("PLHA"); and
- WHEREAS, said Ordinance provides that the above-mentioned Authority shall have the power to lease property from the Pyramid Lake Paiute Tribe for such periods as authorized by law and to hold, manage, or sublease same; and
- WHEREAS, the said Housing Authority has selected subdivision sites located in Sutcliffe, NV and Wadsworth, NV for the development and operation of a homeownership housing project NV 4-19; and
- WHEREAS, plats of the sites have been surveyed and drawn by Meridian Surveying & Mapping, Inc. of Reno, NV identifying each individual lot within the boundaries of the Pyramid Lake Indian Reservation, and
- WHEREAS, the Council and the Authority have agreed that a written lease should be entered into covering land owned by the Tribe which is proposed to be used by the Authority for the development and operation of 6 dwelling units designed as Project NV 4-19; and
- **NOW, THEREFORE BE IT RESOLVED** that the Pyramid Lake Tribal Council hereby approves the resolution for the following Wadsworth sites:
 - (1) Lot Split of existing Lot NV 4-4 W3 and new Lot 4-19 W511 and to include twenty-five (25) additional years for new Lot 4-19 W511 to begin on the accepted amended lease date; the remaining shares of existing lease to remain as recorded.
 - (2) Lot Line Adjustment of existing Lot 4-7 W758 amending the existing Lease Number 651-1-81; the remaining shares of existing lease to remain as recorded.
 - (3) Utilizing unused portion of Lot 124, to be known as 4-19 W124, and to include twenty-five (25) additional years to begin on the accepted amended lease date; the remaining shares of existing lease to remain as recorded.
 - (4) Lot 111, adjacent to existing subdivision, has been surveyed and identified to become an individual lot within the existing subdivision.
