## RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and
- WHEREAS, the Pyramid Lake Paiute Tribe (Tribe) utilizes the 2005 Comprehensive Resource Management Plan and the 2000-2004 USDA-NRCS Pyramid Lake Paiute Reservation Range Inventory as a guide to determine grazing inventory assessments for its twelve grazing units all within the exterior boundaries of the Pyramid Lake Paiute Reservation; and
- **WHEREAS**, the Bureau of Indian Affairs Western Regional Office (BIA WRO) announced on February 4, 2019 that it is accepting grant proposals for FY 2019 funding from the BIA WRO Rangeland Inventory Program; and
- WHEREAS, the Tribe benefits with having the ability to conduct for itself rangeland inventories utilizing available funding from the BIA WRO; and
- NOW, THEREFORE, BE IT RESOLVED, that the Pyramid Lake Paiute Tribal Council, the governing body for the Pyramid Lake Tribe approves the application to request FY 2019 funding from the BIA WRO to conduct the Rangeland Inventory Program activities.
- **BE IT FINALLY RESOLVED,** that the Tribal Chairman or his designee is authorized to negotiate and execute said application with the Bureau of Indian Affairs Western Region Office.
