RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and
- WHEREAS, the Pyramid Lake Paiute Tribe (Tribe) has identified for control certain invasive and noxious (weed) and tree species, primarily Salt Cedar (*Tamarix L.*), Perennial Pepperweed (*Lepidium latifolium L.*), Diffuse Knapweed (*Centaurea diffusa L.*), Purple Loosestrife (*Lythrum salicaria L.*), Scotch Thistle (*Onopordum acanthium L.*), Curly Dock (*Rumex crispus L.*), Russian Olive (*Elaeagnus angustifolia L.*), and Medusahead (*Taeniatherum caput-medusae L.*) within the exterior boundaries of the Pyramid Lake Paiute Reservation (PLPR); and
- **WHEREAS**, the Tribe has conducted annual operations working to control and reduce invasive and noxious weeds and certain invasive tree species on the PLPR; and
- WHEREAS, the Bureau of Indian Affairs Western Regional Office (BIA WRO) announced on February 4, 2019 that it is accepting grant proposals for FY 2019 funding from the BIA WRO Noxious Weeds Program; and
- **NOW, THEREFORE, BE IT RESOLVED**, that the Pyramid Lake Paiute Tribal Council the governing body for the Pyramid Lake Tribe hereby approves the FY 2019 grant application to request funding from the BIA WRO.
- **BE IT FINALLY RESOLVED,** that the Tribal Chairman or his designee is authorized to negotiate and execute said application with the Bureau of Indian Affairs Western Regional Office.
