DOI-DEMD – Assess, evaluate, and promote Development of Tribal Energy and Mineral Resources

## RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

WHEREAS, the Pyramid Lake Paiute Tribe, is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act, (25 U.S.C. 476) and is Federally recognized by the United States Government through the Secretary of the Interior to negotiate with the Division of Energy and Minerals Development (DEMD); and

whereas, the Department of the Interior's Office of Indian Energy and Economic Development, through its Division of Energy and Mineral Development office is soliciting for eligible projects under its – Assess, evaluate, and promote Development of Tribal Energy and Mineral Resources to approve all eligible projects for funding considerations and obtain funding for the development of energy resources on Indian Trust lands for the economic benefit of Indian Mineral owners; and

WHEREAS, the grant program to Assess, Evaluate and Promote Development of Tribal Energy and Mineral Resources allows funding for preconstruction activities including FERC Application submittals for Hydroelectric power generation And Geothermal exploration to determine the potential for renewable power in upstream reservoirs and in the northern geothermal area on the north end of the reservation; and

WHEREAS, the tribe will consider public release of information obtained from the hydroelectric FERC Application and geothermal exploration; and

WHEREAS, the planning and development of renewable energy uses for the Pyramid Lake Paiute
Tribe would allow the tribe reduce its expenditures on non-renewable energy uses and
facilitate a long term project to enhance its economic development opportunities; and

WHEREAS, the proposal being submitted is consistent with planning and development efforts towards other renewable energy resources for the Pyramid Lake Paiute Tribe for the betterment of the Tribe and its members.

**NOW, THEREFORE, BE IT RESOLVED**, that the Pyramid Lake Tribal Council hereby rescinds Resolutions PL 005-19 and PL004-19 which requests a 638 contract for the hydroelectric and geothermal projects; and

**BE IT FURTHER RESOLVED**, that the Pyramid Lake Paiute Tribal council approves, supports, and authorizes the submittal of the proposal to the Division of Energy and Mineral Development – Assess,

evaluate, and promote Development of Tribal Energy and Mineral Resources (CFDA 15.038) for the development of FERC Applications and geothermal exploration in connection with renewable energy projects.

**BE IT FINALLY RESOLVED**, that the Tribal Chairman or his designee by hereby authorized to negotiate and sign all grant awards and other future administrative documents necessary for project award and implementation.
