## A RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE ADDRESSING THE ISSUE OF TRESPASS ON TRIBAL LANDS BY NON-TRIBAL MEMEBRS

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is a Federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and
- WHEREAS, the Pyramid Lake Paiute Tribe pursuant to Article VI, Section 1(i) and (j) of the Constitution of the Tribe and Article V of the Bylaws of the Tribe, adopted by The Pyramid Lake Tribe's Title III, Law and Order Code; and
- WHEREAS, the Pyramid Lake Paiute Tribal Council recognizes the need to address the issue of trespass on Tribal lands by non-tribal members and hereby approves and authorizes the Pyramid Lake Tribal Police as representatives of the Tribe, to revoke the trespasser's privilege to be on Tribal land.
- NOW THEREFORE BE IT RESOLVED the Pyramid Lake Paiute Tribal Council, authorizes the Pyramid Lake Police to issue a Letter of Trespass to a non-tribal trespasser notifying the trespasser that their right to be on Tribal Land is revoked and the trespasser may appeal by sending a letter to the Tribal Council, listing the reason of trespass and the reason they feel the trespass was unjustified. Further, the Tribal Council shall consider the appeal and determine if the person's right to be on Tribal Land shall be restored and Tribal Council shall notify the trespasser of their decision by United States mail.
