## RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and
- WHEREAS, the Pyramid Lake Paiute Tribal Council, pursuant to Article VI of the Constitution and By-Laws of the Tribe, is charged with the responsibility of establishing policy and taking action to provide administrative guidelines; and
- WHEREAS, the Tribal Council has delegated the Land and Resource Committee, a standing committee of the Tribe, with the responsibility to review applications for tribal land assignments and to make recommendations regarding the lands of the Pyramid Lake Reservation; and
- WHEREAS, through a recommendation from the Land & Resources Committee, the Tribal Council approved Resolution No. PL86-18 authorizing a moratorium on new land assignments on the Pyramid Lake Reservation, in conjunction with the status of the existing tribal water system and its overall performance.
- NOW, THEREFORE BE IT RESOLVED, that the Land & Resource Committee, based on discussions with inter-departmental staff from PL Housing Authority, PLHA BOT, IHS, Public Utilities, Transportation and Tribal Land Office on the current infrastructure conditions, the Land & Resource Committee is recommending that the moratorium on new land assignments be vacated and that Resolution No. PL 86-18 be rescinded.
- **NOW, THEREFORE BE IT RESOLVED THAT** the Pyramid Lake Paiute Tribal Council hereby accepts the recommendation of the Land and Resource Committee and vacates the land assignment moratorium and rescinds Resolution No. PL 86-18.

**BE IT FINALLY RESOLVED,** that the Tribal Council authorizes the Tribal Chairman or his designee to effectuate any and all administrative changes to implement this revision.

## CERTIFICATION
