#### PYRAMID LAKE ECONOMIC DEVELOPMENT PLAN WINS EXCELLENCE IN PLANNING AWARD

The Tribe is pleased to announce that the Pyramid Lake Economic Development

Plan has been awarded the Outstanding Plan Award by the Nevada Chapter of the American Planning Association at the 2011 DoBoer Awards for Excellence in Planning.

"The Pyramid Lake Paiute Tribe is pleased to accept this prestigious award as it

represents the tireless work of many individuals who have worked over the years on this project," said Tribal Chairman Wayne Burke. "Over the past 21 years the Tribe had tried 7 times to adopt a plan for economic development but was unsuccessful because of a lack of a community embraced vision for economic development on the reservation. The *Pyramid Lake Economic* 

Development Plan is a great example of embracing a community vision in order to

create the foundation to improve the quality of life for the members of the Tribe today and in the future."

The Pyramid Lake Economic Development Plan was written by Tribal Planner Scott H. Carey and was adopted unanimously by the Tribal Council in March 2011. The

purpose of the plan is to create long term profit-making opportunities and optimum employment opportunities for the Tribe and its Members, and to establish a high quality recreation area at Pyramid Lake. Each element of the plan consists of generalized goals, policies and action steps that the Tribal Government can use to create jobs and growth on the reservation. The plan also outlines the

use of the Pyramid Lake Paiute Economic Development Fund created by Public Law 101-618 to achieve the goals of the plan.


"I would like to thank US Senator Harry Reid and his staff for their support and I am grateful to all of the other Federal agencies who have helped the Tribe adopt this plan," said Tribal Chairman Wayne Burke. "The Tribe looks forward to being able to utilize its economic development fund to create long term jobs and growth on the reservation."

The award for Outstanding Plan was presented to the Tribe at the 2011 Nevada Chapter State Conference held in Sparks, NV. The Nevada Chapter of the American Planning Association's DeBoer Awards are named after Saco Reink DeBoer, author of the Boulder City plan and one of the master city planners of the twentieth century. The awards honor excellence in planning projects and individual initiative. Winners represent the best efforts of the planning community to affect the Silver State in a positive way.

Members of the Pyramid Lake Paiute Tribe turned out on Monday, December 26<sup>th</sup> to cast their votes for members of the Tribal Council.

Four Tribal Council Member seats were on the ballot during this election. Genevieve John, Irwin Mix, Janet Davis and Sherry Ely-Mendes were all elected to the Tribal Council.

In accordance with the Bylaws and Constitution of the Tribe, Tribal Council

Members serve two year terms. The results of the election are unofficial until the Tribal Council of the Pyramid Lake Paiute Tribe meets on January 6, 2012 to approve the election results.

#### **GOVERNOR SANDOVAL VISITS PYRAMID LAKE**

On November 7<sup>th</sup> Nevada, Governor Brian Sandoval conducted a brief visit of Pyramid Lake and met with the Tribe. It is believed that Governor Sandoval is the first sitting Nevada Governor in many years to visit Pyramid Lake and meet with the Tribe is an official capacity.

The visit provided a great opportunity for the Tribe to meet the Governor and his staff and to inform them about the Tribe and Pyramid Lake. Governor Sandoval



met with Tribal leaders and community members at the Pyramid Lake Fisheries Administration Building in Sutcliffe for several hours. During the visit the Governor; met the staff of the Tribe's Police and Ranger Departments, talked with elders from the community, toured Pyramid Lake Fishery buildings, posed for pictures and discussed Tribal-State issues.

At the meeting Governor Sandoval presented Tribal Chairman Wayne Burke with a Governor's Certificate of Recognition for the Tribe winning the Outstanding Plan Award for the Pyramid Lake Economic Development Plan. Governor Sandoval stated during the meeting that he would like to work closer with the all of Tribe's in Nevada and pledged his support to facilitate better communication between the State and the Tribe. The Tribe hopes that this meeting can be the beginning of more substantial discussions and future meetings with Governor Sandoval and his office.



















#### **TRANSPORTATION PLANNING NEWS**

#### Wadsworth Bypass Road



Work continues on the Pyramid Lake Paiute Tribe's number one priority roads project, Wadsworth Bypass Road in the form of design

plans. We have received the 60% plan review back from BIA Transportation and our consultant, Summit Engineering, is working with Nevada Department of Transportation on NDOT's 60% comments regarding the Wadsworth Bypass Road. This plan will soon be taken to the council for their review and approval. The alignment for the location of the road has not changed from the approved 30% plan. The new alignment will begin at a new intersection approximately 1,000 feet east of the I-80 Smokeshop. From this new intersection the new road will run north, proceeding just west of the new pump house for the water well and up the hill, continuing slightly west of the transfer station and

connecting to the existing State Route 447 at the big curve near the S bar S road. Our consultant is working with the Nevada Department of Transportation to design the road to NDOT standards. This will allow the new bypass road to be designated

State Highway 447 when agreement is reached between NDOT, BIA and the Tribe. NDOT is working to obtain funding to construct this new section of road. If NDOT is successful in finding full funding for the construction costs, then the Tribe would not have to use Tribal roads construction funds for this project. NDOT has stated that they will only maintain the

new bypass alignment or the existing State Route 447 which currently runs through Wadsworth but not both sections.

Transfer of rights of way documents will have to be signed between NDOT, Pyramid Lake Paiute Tribe (PLPT) and Bureau of Indian Affairs (BIA). The planning documents are scheduled to be completed before the end

#### **Pelican Point Road**

We have received the 30% plan review back from BIA Transportation regarding the Pelican Point Road and will soon take



this plan to the council for their review and approval. The design consultants for this project have been forwarded the BIA comments and will

proceed to incorporate the comments for the plans. The proposed alignment of the new road has changed from the existing dirt road location to a location south of the current intersection with state highway 446. This new intersection is proposed for safety reasons to improve sight distance for vehicles rapidly approaching from the north on the paved highway. These plans include improved access road and improved parking areas for the boat docks and beach areas. This design project is an ARRA funded project and the plans have to be completed before

September 30, 2012. We will have a more complete cost estimate when the plans are completed which we will be able to use when projecting the construction schedule.

#### **ENVIRO-WETLANDS**

My name is Tanda Roberts and I am a Pyramid Lake Paiute Tribal member. I am the Environmental Specialist for the Tribe's Wetland Program. The Wetland Program's primary goal is to protect and restore wetland resources for economic. cultural, environmental and human health benefits. Our program is intended to ensure that the reservation's wetlands and its resources are well cared for. The Wetland Program Plan is designed to address three main core elements. These elements include monitoring and assessing, regulatory, and restoration and protection. Our department's continued collaboration of all PLPT Environmental Department programs and other outside agencies, that have the same objectives and goals, helps to guarantee that the reservation's water quality meets or exceeds standards. #### THE WADSWORTH COMMUNITY CENTER

This building project was conceived in 2006 and it was to provide a community building for youth and community activities in the Wadsworth area. Originally the project was to encompass approximately 10,000 sq. ft. and include a large central area/gym, restrooms/locker

rooms, office/meeting rooms and kitchen. This project would instill pride in the community with a sense of bringing the people together. The structure could also provide a gathering place in a time of emergency. The needs

of the community drove this idea, we have seen and heard that the kids have no place to go and have nothing to do.

The Wadsworth Community Center Planning Committee was formed to assist Tribal staff in planning and reviewing construction documents for phase I which had to be phased down to a 3,000 square foot building because of cost constraints due to the \$495,000 Housing and Urban Development (HUD) special grant that was awarded to the Tribe in 2006. This

structure is planned be built on the north side of Eighth Street near the Jackson Street intersection. The architect's current schedule for completion of construction for this building is July of 2012.

Phase II of the project will include the

gymnasium, restrooms/ locker rooms, fitness center, diabetes office, parks & recreation office, and other functional rooms.

Phase III was identified as and after-school tutoring/computer lab. PLPT contract and grants currently are in the process to apply for the Indian Community Development Block Grant (ICBDG) for this phase.

Other communities have built facilities/ gyms that function to reduce the health risks of the Native American community and provide a center for community functions. Costs for these facilities range from approximately 1.1 million dollars to 2.78 million dollars. We have our current architect's estimated cost for a 17,000 sq. ft. facility at 4.5 million dollars.

This center will for the benefit of the entire population of the Pyramid Lake Paiute Tribe and surrounding areas.

We need to ask for community support to have a chance to build this facility. This will take a lot of cooperation between the council and the people. We will need up to 4.5 million dollars to build a quality facility. Part of this money can come from grants and the rest could possible come from Tribal settlement funds i.e., Vidler or a portion (7.89%) of the 57 million interest due from the TROA agreement. Each grant found will reduce the percentage needed to build the health center/gym. We as people need to ask ourselves; are we willing to provide ourselves and our youth with the facilities that we all know that we need.

### **Notice of Public Workshops**

December 12, 2011

The Bureau of Water Quality Planning of the Nevada Division of Environmental Protection (NDEP) is proposing to review the water quality standards for the Truckee River contained in Nevada Administrative Code 445A.184 through 445A.190. The current standards were last updated in 1993 and a new review is deemed appropriate. In the past 18+ years, there have been significant changes in the river management, supporting science, and the Pyramid Lake Paiute Tribe has added water quality standards to their waters which warrant the review. Additionally, the Cities of Reno and Sparks, Truckee Meadows Water Reclamation Facility, Washoe County, Truckee Meadows Water Authority are pursuing a 3<sup>rd</sup> party review of the existing nutrient TMDL (Total Maximum Daily Loads) which defines the allowable nutrient loads to the Truckee River. NDEP promotes the review of water quality standards prior to the development or review of any TMDL, as appropriate.

A workshop will be held at the following location at the date and time indicated:

January 12, 2012 3:00 - 5:00 PM Nevada Department of Wildlife Conference Room 1100 Valley Road Reno, Nevada 89512

The purpose of the workshop is to solicit initial public comments on the proposed review. The workshop will consist of a brief presentation of the review process, and expected future documents and public meetings, followed by a question and answer period. No items will be voted on and no actions will be taken. Written comments on the proposed revision may be submitted to NDEP until February 3, 2012. Additional workshops will occur to present any proposed revisions, and to solicit comments on specific recommendations.

#### PARENT INVOLVEMENT - THE KEY TO SUCCESS By Sherry Ely Mendes

The first months of school can be a hectic and anxious time for parents. It may feel even more intimidating if your child has never



attended child care before entering the formal K-12 education system.

Unfortunately, many Native American families have a history of negative experiences with the public school system. Putting your best foot forward and getting involved in your child's education can create a positive experience for you and your child. Once you have opened the door, you will find that there are many different ways that you can be become involved.

Research indicates that parent involvement can result in many positive outcomes in children. According to the

Michigan Department of Education (2001), here are some great reasons to get involved in your child's education:



- Increased motivation and better selfesteem.
- Lower rate of suspension,

Better school attendance,

- Decreased rate of drug and alcohol use, and
- Fewer instances of violent behavior.

What a great payback for just a small amount of time each day. Below are some simple ways to get involved and show your child that his or her education is important to you.

#### **Parent Involvement Tips**

 Do homework with your child in the evening. It will give you the opportunity to be the teacher



and help your child develop good study skills.

- Read at home with your child. Just 15 minutes of reading at home can increase your child's reading skills at school which increases school success.
- Role model the joy of reading! Get out those magazines, novels, newspapers etc. and enjoy some quiet reading time!
- Provide a routine time and a quiet place to read and/or do homework.
   Sticking to a routine helps everyone stay on track.
- Model the value of learning, selfdiscipline, and hard work. Have

discussions about these subjects so your child can ask questions about what this means to you.

- Set goals for your child and help him or her to reach them. Be realistic and encourage special talents.
- Develop a relationship and stay in touch with your child's teacher.
- Volunteer in the classroom when possible or offer other assistance such as newsletter writing, sharing projects, doing cut outs, reading to the children, offering to teach your cultural skills, being a

storyteller, etc.

It is the basis of

many Tribal beliefs that our children are our future and that the entire family or Tribe is involved in raising our children. Being an involved parent at the school level and at home will strengthen this bond and make a brighter future for all.



A special "Thank You" goes out to Barbara Franks who came all the way from Alaska to share her experience of the loss of her son to


