The Great Wisdom Center is the 'shell', the body, the school and gathering place for individuals of all beliefs, culture, educational backgrounds and ages to cultivate their personal pearls of wisdom and heart and to share in the wondrous journey of others.

Much confusion remains with regard to the changes of the Tribal Fishing regulations. Below are the two press releases that were intended to inform everyone about the changes. Following the press releases is a summary for further clarification. More postings announcing clarifications will be provided to vendors and businesses frequented by anglers.

NOVEMBER 20, 2007:

Fishing is not closed, the fishing season dates remain the same.

To protect the breeding stock, areas near the net pens will be closed from March 15 through May 16 of each year.

Down riggers are still allowed for use at Pyramid Lake.

NO CHANGE IN PERMIT PRICES

Barbless hooks are to be used at all times – existing barbed hooks can be crimped.

No fishing is allowed from any boat dock, and the area near boat docks is closed at a 100 foot radius from any boat dock.

Day use ONLY on east side of Pyramid Lake – no overnight camping allowed for non-tribal members.

No alcohol allowed on Sutcliffe, Marina, or Long Beaches. These beaches are designated as family beaches.

Fishing derbies or fishing tournaments are limited to two days. An application is required to be completed by any person or party wishing to hold a fishing derby or fishing tournament at Pyramid Lake.

Fishing guides and fishing charters are amended. Please see regulations at www.plpt.nsn.us

No metal detectors allowed at Pyramid Lake.

Anglers are required to report catch information at Pyramid Lake Creel Stations at the Nixon Store (Nixon) or at the Pyramid Lake Store (Hwy 445). Gathering creel data is critically important to fishery management and fishery production.

Amended regulations effective October 1, 2007.

DECEMBER 24, 2007:

Section 1.1.3 is amended to require fishing derbies with zero to five-hundred (0-500) participants shall pay \$3.00 per person per event, and fishing derbies with five-hundred and one and more (501 and more) participants shall pay \$5.00 per person per event to be paid by the host, promoter, organization (person in charge organizer) and shall be due at the conclusion of the derby event. Valid Pyramid Lake Paiute Tribal fishing and boating permits are still required.

Each fishing derby host, promoter, organization (person in charge organizer) are required to complete their request through an established application process. Interested persons may contact the Tribe to inquire further information.

This amendment is effective December 21, 2007.

The Net Pen area in Sutcliffe is closed at 1,000 feet to the north and 1,000 feet to the south of the inlet to the Pyramid Lake Fisheries freshwater attraction channel. Restricted areas include 200 feet from shore (beach or rock outcropping) where shore anglers can fish, which means practically anywhere along the perimeter of the lake. Boats anchored or trolling in such restricted areas will be cited.

The Tribe is working on the regulations as circumstances change and new situations present opportunities to further change and adjust the regulations. It is necessary to make adjustments as enforcement reach ambiguity and grey areas that require further clarification. The Tribe is also analyzing its financial reports to support any potential for increasing fees or other fee requirements as resources are expended to provide certain protection and enforcement measures.

The Nixon Store has been closed temporarily as it is transitioning toward a conjunctive collaboration in management. The Store had been operating in a deficit and it has forced the I-80 Smoke-shop to also operate in a deficit. The Tribe has an opportunity to operate it in a conservative fashion to build its credibility for future options in financing support. There is capital improvement needs, a shift in merchandising, and improvement to the fuel services. The Tribe is focusing its attention in a business manner with its decisions.

The Tribal Finance Department is continuing its diligent effort to bring the financial management current with its operations. The Tribe has relied heavily on consultants for too long and it has brought the Tribe to a necessary change with this operative to wean itself from that dependency. One by one the Finance Department is auditing each grant and contract program to assure compliance and bring the accounting requirement to meet the performance and operational requirement. This disconnect has caused a number of programs to become non-compliant and therefore it is critical to clear the non-compliance to eliminate the contingent liability.

The Tribe remains challenged to complete the 2006 and 2007 audits, which are underway. In addition, the Indirect Cost Rate proposals are due for 2006, 2007, and 2008. All of this catching up has been on a fast track and along with these obligations, the accounts payable is nearly caught up. The Tribe had not paid current its bills from 2006 and throughout 2007 it was behind until now. The Tribe has operated in a very costly manner due to delinquent fees, late reporting charges and penalties, and in some cases negligence in paying bills.

All of this negative type activity has come to a stop and the operations are being managed and moved with caution and scrutiny to prevent abuse and manipulation. It is exciting to know that the Tribe will becoming more self sufficient with relying on internal controls that are developed with sincere interests to protect Tribal financial resources and investments. Investing back into the tribal operations by utilizing experience and qualifications will have its lasting benefits.

The realty management of tribal properties is taking on a new approach to property management. Te tribe has not taken advantage to it full capability or capacity in receiving highest returns on its property. Property acquisition and brokerage are other components that also have not maximized its return. The tribe has not been able to realize its full latitude with property management and will not begin to exercise options to receive the maximum benefit with our realty management program.

The Tribal Appropriations Committee meets regularly to discuss ongoing and pressing financial issues of the Tribe. A first quarter meeting is scheduled with the Tribal Council during the first week in April after the first quarter books can be closed. Understanding the general accounting principles and business methods of operations will provide greater insight for supporting tribal development and growth.

On the legal front, the High Desert Recreation litigation has moved into mediation and at this time legal counsel is making all communications to resolve outstanding issues and potentially the litigation. The securities fraud hearing with Mine Central is scheduled for April 18, 2008. A full report to the Tribal Council will be forthcoming. The *Crosby Lodge v. NIGC* is also continuing forward. Enforcement of federal requirements is necessary by any tribe who engages with activity subject to any such federal law – the Indian Gaming Regulatory Act.

A code of ethics was introduced for the Tribal Court staff. A more comprehensive code of ethics should be reinstated for all officials associated with activities of the court. This includes the court staff, judges, the Pyramid Lake Police Department, the Law & Order Committee, and the Tribal Council. It should provide equal application for everyone to prevent personal influence, family politics, and unfair law/regulation development. Work is underway to develop the code of ethics and it should be done where it will not later be rescinded such as the occurrence in 2006.

Streamlining operations is another focus for overall tribal operations. There are many committees, some say too many committees. Tribal council involvement should also be limited to present efficiency in reporting and allow greater public involvement. Two boards in particular are politically heavy with majority of its membership being tribal council members. When no reports are submitted by the council members serving plus disallowing public involvement, it is not efficient. By reducing the number and providing that one Tribal Council member serve as liaisons to each board and committee, it will bring about better communications and responsibility.

Gaming development received a positive boost where the Tribal Council decided to solicit proposals for gaming development. The Council is also supporting the potential to develop a golf course. It realizes that development is important for benefits to the membership. For thirty years no major development occurred at Pyramid Lake and it appears as if maybe there is a greater force working to prevent any major development for the Tribe. Either is it the case, the opportunity is upon us and securing positive and effective relations that will prove most beneficial for long term benefits.

Negotiating the gaming compact is important to provide for long term opportunity with respect to development and investment. Key terms for renewing the tribal compact are the length of the term and clarification of jurisdictional responsibilities just to name a couple. The compact is a critical component for tribal gaming even though the reservation is within a gaming state.

The tribal referendum is scheduled for May 31, 2008 for the Truckee River Operating Agreement (TROA). The Truckee–Carson–Pyramid Lake Water Settlement Act (PL 101-618) will be completed when the TROA becomes implemented and is in full effect. An important component comes into view; the economic development fund. The economic development plan must be submitted to the BIA and it must be developed in consultation with the BIA, and it is not required to be approved by the Secretary of Interior. Public meetings will be scheduled, please be on the look out for the meetings.

Our intention is to provide services and welcome comment and concerns about tribal operations.

VICTIM SERVICES

When someone you know is being abused

Maybe your friend or relative tells you everything is OK or refuses to talk about it. What can you do if someone you know is being abused? Here are some ways to offer support.

- Find out about services for domestic violence victims in your area.
- Educate yourself. The more you learn about domestic violence, the easier it will be for you to understand and support the person you are concerned about.
- Let the person know you care and are concerned for her/his safety.
- Offer whatever support you feel comfortable offering.
 Some examples: a person to call day or night; a safe place to stay in an emergency; moral support while s/he makes phones calls to a hotline or shelter, speaks to a counselor, or goes to get an Order of Protection.
- If s/he is willing to talk about the abuse, listen. It is very hard for domestic violence victims to talk about abuse; if they sense you don't believe them, they may feel like authorities won't either. Try not to judge or give advice.
- Offer a hotline number.
- Abuse ca erode a person's self-esteem. Remind your friend or relative of her or his strong points.
- Let the person know whatever s/he is feeling is OKanger, terror, embarrassment, frustration. What is not OK is the partner's violence.
- Be patient.
- Recognize your limits. If s/he asks you to do anything you are uncomfortable with, say so.

Apply Now for Range Camp



Caliente, Nev., March 6 — Applications are now being accepted from high school students to attend the Nevada Youth Range Camp to be held June 15-21 at the U.S. Forest Service's Big Creek Campground in central Nevada. Applications must be postmarked by April 28.

"Range Camp is a teenager's best opportunity to learn about Nevada's desert and mountain rangelands," said Jim Gatzke, youth camp coordinator. The Society for Range Management operates the week-long camp for 14-18 year olds from Nevada and eastern California.

Campers will have the opportunity to learn from range management professionals who are knowledgeable in the ecology and management of the Great Basin's desert and mountain rangelands. Students learn basic surveying and map reading, identification and importance of rangeland plants, evaluation of sagebrush and woodland ecosystems, wild-life surveying techniques, evaluation of stream health, and many other topics related to rangelands. While the camp is educational, it also offers an enjoyable, outdoor experience with activities such as swimming, fishing, hiking, volleyball, horseshoes, campfires and photography.

Interested students must submit an application, health form, and letter of recommendation from a qualified adult. The cost to attend Range Camp is \$150, which includes meals and camp activities. Applicants can be sponsored to attend Range Camp by contacting their local conservation district or other organizations. If sent by e-mail, letters of recommendation must be on the adult's official letterhead or must be a scanned copy of the adult's letter and signature. Applications must be postmarked or emailed by Monday, April 28, 2008. Approved applicants will be notified within two weeks.

Camp is held every June at the US Forest Service Big Creek Campground in central Nevada's Toiyabe Mountain Range. The Toiyabes are one of Nevada's most impressive mountain ranges with several peaks over 10,000 feet in elevation. June is an ideal time to be in the Toiyabes when numerous wild-flowers are in bloom and the vegetation is green from the recent snowmelt.
