Smith Takes Fifth Place In Oakland — Punt, Pass, and Kick

Nick Smith, 9, is the son of Craig Smith of Pyramid Lake, and Maureen Smith of Fallon. Nick is in the 4th Grade and attends West End Elementary in Fallon, Nevada. Holcombe and Smith both finished in fifth place in their respective competitions, Holcombe in the boys 10-11 year olds and Smith in the boys 9-10 year olds.

"My favorite sport is football. I heard about Punt, Pass, and Kick and I wanted to try out for my first year," Smith said. "I won in Fallon and I won in Gardnerville so now I'm in Oakland. I think I did pretty well. I think my pass was the best."

The days events began with the actual competition, which was held at Brookfield Village Park, a neighborhood park about a mile south of McAfee Coliseum where the Raiders play. The competition began at 9 a.m. under cloudy skies. The field was wet and muddy due to heavy rain that fell on Saturday and early Sunday morning. Intermittent showers fell while the players were warming up, but there was no rain during the competition.

Participants were scored on how far they could punt, pass and kick a football. Each participant was allowed one punt, one pass and one placekick off a tee. The combined distance off all three was added together to determine each participants score.

After the competition, the participants and his or her parents waited anxiously while the scores were calculated. A few were elated to find out that they had won while most took the bad news in stride.

Each participant received a plaque award for having made it to the team championship. The day didn't end with the competition. Each participant and their parents received complementary tickets to the Raiders game against the Atlanta Falcons. Before the game, they all went onto the field at McAfee Coliseum, where each one threw a pass to the oos, aahhs and cheers of the crowd.




Solar Energy for the Pyramid Lake Paiute Tribe (PLPT)

Black Rock Solar conducted an initial assessment of the energy use of the PLPT. A similar program was completed at Natchez Elementary School. The Tribe is currently working to identify financial means to complete these projects.

There are 165kW of viable solar installations to be done in Nixon for various tribal offices and facilities, with an additional 24 in three small installations, for a total of 191kW. The rebates that have been issued are for \$4.60 per watt. At

\$6.25 per watt total construction cost, the total cost would be \$1,193,750, of which \$879,000 would be available as rebates. Funding on the order of \$314,750 will have to be raised to do these projects.

Building 191kW of solar would save approximately \$42,020 per year, for a payoff time of eight years at current rates. Note that this calculation was made prior to the recent rate increases by NV Energy, so the payoff date could come sooner. Over the course of the expected 25 year lifespan of the projects, they



would save approximately \$1,050,500.

On the four meters at the Pyramid Lake High School, there is huge usage on one meter, smaller use on three others. If we did 10kW each on the CHS and Well, and 35kW on the ball field and 50kW on the main school, the total would be 105kW (\$482,000 in rebates at \$4.60 per watt) with an estimated site host contribution of \$173,250. Annual energy savings would be \$24, 570, for a payoff of eight years.

The Main School meter, however, has a massive energy use, some 282kW worth, and could be eligible for 3rd party ownership scenario, should the PUC and Assembly allow it.

It's also worth noting that in the instances below where the rebate doesn't fully cover the energy use, an additional rebate application and installation could be done in the following program year to offset that use.

The Tribal Health Clinic use 60kW, but would be only eligible for 30kW (\$138,000 at \$4.60 per watt), and would require site host contribution of \$49,500. Annual savings would be \$7000, for a payback of 8 years.

JUDCIAL WORKING GROUP SUBMITS THEIR RECOMMENDATIONS TO THE TRIBAL COUNCIL

There were a number of complaints that had been submitted to the Pyramid Lake Paiute Tribe. Although several of them had already been responded to;

- All Administrative and Tribal Court Staff shall be familiar with the Pyramid Lake Law and Order Code and the Court Procedures. A signed agreement should be kept on file verifying that all staff had read the code and procedures
- All current Pyramid Lake Paiute Tribal Polices and Procedures will be followed as written to ensure individual rights or civil rights are not violated; Any Pyramid Lake Paiute Tribal Court policies or procedures that are outdated or do not follow the tribe's Law and Order codes will be amended by the Court Administrator. Amendments will follow the tribe's amendment procedures before any policies go into effect.
- All Administrative Court Staff and Court Staff will follow the scope of their job duties as outlined in their job descriptions. Other duties as assigned should be removed from Court Staff job descriptions. If the grant includes other departments, all departments should be made aware of the grant objectives.
- All Administrative Court Staff, Chief Judge, Associates Judge, Adult Probation, Juvenile Probation, Advocates, Lay Advocates will sign a Code of Ethics (Approved by Pyramid Lake Paiute Tribal Council 04/18/2008) and Oath of Confidentiality. Signed documents will be kept on file in the Employee Personnel file for regular employees or with the Contract for those contractual employees. For other advocates who practice in our court, theirs should be kept on file in the Court Administrators Office.
- All Court Staff should receive training on current Indian Law at the University Of Nevada Judicial College, or some other institution that offers trainings on current Indian Law.
- All Administrative Court Staff and Court Personnel will maintain a professional demeanor with all individuals or agencies who utilize the Court Services.
- All Administrative Court Staff should have Cultural Sensitivity training.
- The Administrative Court Staff will make a binder containing the Pyramid Lake Law and Order Code and Court procedures should be placed in public area where any individual can access it. Copies of the Law and Order Code and Court Procedures will made available to public at a minimal charge.
- All court forms should also be placed in the same area with brief description of how to fill out the form. If there are questions Court Staff should be on hand to answer any questions.
- If Tribal Court has a grant, then Staff must be aware of the objectives of the grant and stay within the scope of work outlined in the grant. If other Tribal Departments are mentioned in this grant, it will be the Court Administrators responsibility to inform all department effected.
- MOU/MOA should be established between, but not limited to, Court Services and Health Center, High School, Mental Health, Social Services for the protection of all parties. All MOU/MOA will follow Law and Order Code guidelines and protocols before that are enacted.
- Advocates should be located in another building outside of the Pyramid Lake Tribal Court Building. It is also recommended that the court Advocate be hired part-time to allow clients more time with their advocate to discuss their cases.
- The Working Group recommended a desk audit of the Court Administrator and the Court Staff. The desk audit will be preformed by an outside evaluator/consultant.
- Administrative Action on one individual recommended by the working group after all of the complaints were reviewed. One oral reprimand to be issued.

there were a few of them that seemed unresolved.

At the July 2, 2008 Tribal Council meeting a group came forward and requested that they be reviewed and action be taken. Vice Chair Eben was not present at this meeting when a motion was made by "Council Member John made a motion for at least three Tribal Council members meet with Law and Order Committee to review the complaints that have not yet been resolved. The motion was seconded by Councilmember Mendes. Votes were taken. Motion carried." It was stated that 10 days should be enough time to accomplish this task.

The Working Group meetings held on July 7, 11, and 17, 2008. A meeting was also scheduled August 28, but was cancelled until September 4, 2008. Final working group meeting was held on October 9, 2008. There were numerous issues that needed to be addressed and ten days was an unfair amount of time. Of these meetings thirteen recommendations to better the Judicial Program and one recommendation of Administrative Action was made by the Working Group, and they are as follows:

"Advancing Leadership"

I seek re-election and I want to share the strides completed and the continued engagement with the challenge facing the tribe. Serving 20 months; stopping the uncontrollable spending and the mismanagement of tribal funds was major. By December 2008, the 2006 and 2007 audits and the 2007, 2008, and 2009 Indirect Cost Rate proposals will be completed. The Tribal staff and the Tribal Council deserve recognition for their diligence and support.

Many controls have been instituted to bring accountability with budget and financial responsibility. Enforcing policies has been brought to a level where the Administration will not circumvent or go against policy, laws, or business objectives. Optimization is business fundamental and increasing tribal revenue opportunities have begun.

Enforcing policy has not been a popular thing to do, but it is the right thing to do. Funding agency sanctions and restrictions was common; and now the tribal operation is more legitimate and without underhandedness.

Economic development has not produced for a number of reasons.

- Developing a business council and/or corporation •
- Implement the Economic Development Plan
- Increasing Council terms to four years; because changing direction every two years is not progress
- Educating the Council to avoid holding up ideas .
- Financial order will provide a better means to justify tribal financing opportunity

The model of the Tax Spending Plan is reasonable for the Tribal budget to collect and hold tribal revenue for future budgeting. Spending tribal revenue as quick as it is earned prevents operating toward a balanced budget.

Constitutional change is a leadership responsibility to afford the opportunity for membership participation in the Secretarial Election process. The changes are proposed to increase sufficiency and efficiency, and most importantly voter participation.

Tribal natural resources are invaluable:

- Maximizing use of tribal water resources
- Enforce water quality standards
- Implement TROA
- Assure resource preservation and conservation to meet overall Tribal objectives
- Encourage alternative energy development

Technology is critical in the professional realm of general tribal resource management. Having technical and socio-economic understanding of the overall tribal welfare can address critical management issues moving us toward self-sufficiency and self-reliance.

Education is the key for all generations. From preschool to post secondary education

The following is provided from the Constitution and Bylaws and from the Tribal Election Ordinance.

AMENDMENT II CONSTITUTION AND BYLAWS

Article III, Section 4, of the tribal constitution shall be amended to read as follows:

"Councilmen shall hold office for a term of two years or until their successors are elected, except that at the first election of Councilmen under this Amendment to the Constitution, the five candidates receiving the highest number of votes shall hold office for two years and the five candidates receiving the next highest number of votes shall hold office for one year. Thereafter, every year five Councilmen shall be elected for a term of two years."

Article IV, Section 1, of the tribal constitution shall also be amended to read as follows:

"The first election of a tribal council under this Amendment shall be called, held and supervised by the present tribal council within 30 days after the ratification and approval of this Amendment, and thereafter elections shall be held every year on a date to be determined by the Pyramid Lake Paiute Tribal Council and announced at least 30 days in advance. The election date shall fall between December 26 and 30."

Date: Feb. 23, 1962

AMENDMENT III

Article III – GOVERNING BODY, shall be amended in its entirety to read as follows:

Section 1. The governing body of the Pyramid Lake Paiute Tribe shall consist of a chairman, vice-chairman, and eight (8) councilmen, and shall be known as the Pyramid Lake Paiute Tribal Council.

Sec. 2. The entire tribal council, including the chairman and vice-chairman, shall be composed of ten (10) members, and shall be elected through secret balloting by the eligible voters of the tribe.

Chairman and Vice-Chairman. The chairman and vice-chairman shall be elected through popular vote and each shall serve for a term of two (2) years or until their successors are elected. Candidates for the offices of chairman and vice-chairman shall be members of the Pyramid Lake Paiute Tribe, twenty-five (25) years of age or older at the time of election (see Bylaws, Article II - QUALIFICATIONS FOR OFFICE), and must have lived continuously on the Pyramid Lake Reservation for not less than one (1) year immediately preceding his announcement of such candidacy. The chairman and vicechairman may serve two (2) terms in succession.

Councilmen. The councilmen shall be elected by eligible voters of the Pyramid Lake Paiute Tribe and shall serve for a term of two (2) years or until their successors are elected; except that at the December election following the adoption of these amendments half of the councilmen receiving the highest number of votes shall serve a two (2) year term and the remaining half shall serve a period of one (1) year. Candidates for councilmen shall be members of the Pyramid Lake Paiute Tribe, twenty-five (25) years of age or older, and must have lived on the Pyramid Lake Reservation for not less than one (1) year immediately preceding his announcement of such candidacy. All councilmen shall serve any number of terms in succession.

our tribal members can achieve success from communal support. I will do what is necessary to continue to support our reservation communities and our youth through their education endeavors and will continue motivate post-secondary education choices.

The social challenges require accepting choices we make. Each decision brings about consequences and we must recognize the good or bad consequences of our decisions. Factual understanding is important and must be the basis for what we know and believe.

Preserving cultural and traditional knowledge is important for the continued preservation of the Tribe. All resources touch upon our culture, and it is important that we use traditional knowledge demonstrating our teachings to younger generations.

I have personal interests with singing traditional songs, playing handgames, attending ceremony, and enjoying music. I have volunteered on Fernley's American Youth Soccer Organization (AYSO) Board for four years. I have coached in AYSO for five years, and have been a referee for six years.

All Candidates. Persons who were serving in the Armed Forces, attending formal education or vocational training, or persons who were hospitalized for much length of time thereby making it necessary for these people to temporarily leave the Pyramid Lake Reservation will be exempt from the residency provisions outlined in Article II, Section 2 (a) and (b) of the constitution and bylaws. The decision of the eligibility of candidates by the tribal council shall be final.

Sec. 3. The tribal council so organized shall elect from within its own members or from other members of the tribe a secretary, treasurer, and such other officers and committees as it may determine necessary.

AMENDMENT IV

Section 2 of Article IV - NOMINATIONS AND ELECTIONS shall be amended to read as follows:

Sec. 2. Any qualified voter of the tribe who is twenty-five (25) years of age or older may announce his candidacy for chairman, vice-chairman, or councilman by notifying the secretary of the tribal council, in writing, of his candidacy at least fifteen (15) days prior to the election. It shall be the duty of the secretary to post the names of all candidates who have met the requirements at least ten (10) days before the election. FEB 6,1973

CHAPTER 9.01 GENERAL PROVISIONS

CHAPTER 9.02 ELECTION BOARD

99.02.020. Duties and Responsibilities of the Election Board. The Board shall be in charge of all election procedures including the administration of special elections except as otherwise specified in the Constitution and By-Laws of the 9.03 Tribe.

9.02.030. Duties. The Board shall:

(a) Prepare a list of qualified voters and post the list on the reservation at least forty-five (45) days prior to the date of the election. 9.03

The Election Board shall investigate the residence of any person on the list of qualified voters whose residency has been questioned by a written challenge from another Tribal member, or upon the Election Board's own motion, 9.03 by notifying the person in writing that his/her name will not appear on the final 9.03 Eligible Voter's list unless the person establishes residency on the Reservation for at least one year by submitting to the Election Board one of the following, or other documentation deemed sufficient by the Election Board, by the deadline provided in the notice: 9.03

i. If living in MHOA/Rental Home of the Pyramid Lake Housing Authority: 9.03 An affidavit from the Tribal member stating how long he/she has lived at 9.03 the residence and a written statement from the Executive Director of the Pyramid Lake Housing Authority or representative thereof stating how 9.03. long the member has continuously resided at the residence.

li. If living in a Home Not owned by the Member: An affidavit from the 9.03. Tribal member stating how long he/she has lived at the residence and either (a) an affidavit from the homeowner stating how long the Tribal member has resided at the residence; or (b) a copy of the Tribal member's driver's license showing residence.

lii. If living in a Home that the Member Owns: An affidavit from the Tribal member stating how long he/she has lived in the home signed by two witnesses who are not immediate family members; or a copy of at least two (2) bills which show the Tribal member's name, address, and date showing at least one year of residency on the Reservation. 9.03

(b) Submit to the Tribal council the list of qualified voters, the Tribal council shall approve the list of qualified voters fifteen (15) days prior to the elec-9.03 tion. The approved list of qualified voters shall be used at the polls.

(c) Prepare ballot forms for use at the polls. Candidate's names shall be listed according to the date and time the Tribal Secretary receives the letter an-9.03.100. nouncing candidacy. The number of ballot forms prepared shall be equal to the 9.03.110. number of qualified voters plus twenty (20.

6.See that each voter is permitted to mark ballot in privacy. After ballot has been properly marked, the voter will cast ballot into the ballot box.

7. Tally the ballots at the close of the polls shall be done in private by the Election Board.

8. Upon completion of tally and total, the Report of Tribal Election form will be certified by members and posted immediately. Board will certify two (2) originals, one for file and one for BIA, and copies will be posted.

9.All tribal elections for officers and councilman shall be canvassed and certified by the Board within one day after such election.

10.All election materials shall be kept by the Election Board under lock and key for thirty (30) days in the event of an appeal or order of recount. The ballots will be placed in an envelope, sealed, and placed with the voters' register book in the ballot box and locked. The ballot box shall be secured at the tribal administration office. The Election Judge shall follow through on all procedures. The Election Judge will present results at the next regular council meeting.

11. The Election Judge will act as arbitrator to settle any disputes. In the event of the Judge's absence, Election Clerk will settle disputes.

9.03.032.	The Tribal Council shall certify the legality of such nominations.
9.03.040.	Calling of Elections.
9.03.041.	The Tribal Council shall call the election of officers and councilmen at lease thirty (30) days prior to the date of all elections in accordance with Article IV, Section 1 of the Constitution.
9.03.050.	<u>Electioneering.</u> No electioneering will be permitted within two hundred (200) feet of the voting place during the hours the polls are open.
9.03.060.	<u>Spoiled Ballots.</u> If, during the tallying of the votes, the members of the Election Board are unable to determine the intended choice of the voter from the ballot, that portion of the ballot shall be rejected. The Election Board will reject a portion of a ballot if a voter: Votes for more than one (1) Chairman
	Votes for more than one (1) Vice-Chairman
	Votes for more than four (4) Councilmen
9.03.080.	Only the portion of the ballot that is improperly filled out will be rejected; the remainder of the ballot will be counted. <u>Unused Ballots.</u> Ballots unused at the end of the voting shall be clipped together, marked "Unused" in ink and returned to the ballot box at the end of the tallying.
9.03.090.	<u>Tie Vote.</u> In the event of a tie vote, the ballots shall be recounted imme- diately by the Election Board. If the tie vote is confirmed, the Tribal

Council shall determine an equitable method of election.

(d) Supervise all elections as follows:

1.Hold the place of voting open between the hours of 6:00 am to 6:00 9.03.111. pm without intermission on the day of the election.

2. Maintain the orderly conduct of all persons within and surrounding the polling place and request the Brand of Law & Order to assist, if needed. 9.03.112.

3. Have the responsibility of permitting only those on the qualified voters list to vote.

4. Require each voter to sign the voter's register before receiving a ballot. Any person whose name does not appear on the approved qualified voters list 9.03.133. will not be given a ballot. No person shall be allowed to vote by absentee voting or to vote more than one time.

5.Be responsible for the safe keeping of the ballots and ballot box.

Appeals.

Appeals shall be heard by the Pyramid Lake Tribal Council at the next Regular or Special Tribal Council meeting and the decision of the Council shall be final.

Any appeal protesting the conduct of the election or the election results shall be presented within seventy-tw0 (72) hours following the posting of election results (time will be recorded on it) to the Tribal Secretary and none shall be considered thereafter.

Special Elections. The conduct of Special Elections outlined in Article VIII and IX of the Constitution and By-Laws of the Pyramid Lake Paiute Tribe shall be the same as the election of the Council, except where constitution provides differently.

Time of Special Election. A special election shall be scheduled not more than sixty (60) days from the time the Tribal Council calls the election. If the next regular election is no more than one-hundred twenty days (120) days from the call of the special election, the special election shall be held wit the next regular election.

Public Utilities Update:

The Public Utilities District has been critically assessing current projects, activities and its service to the public. These items however come with a huge cost. We've begun by assessing the financial elements. These include financial evaluations of payment history, billing, and operational and maintenance expenditures for domestic water, curbside service, and transfer station costs. We currently have Loren Decker and Johnny Dunn who are dedicated to dealing with solid waste (transfer station, lake management, and curbside service) while sewer, domestic water and treatment are maintained by Eric Ingraham. These individuals are dedicated to providing these services to all three communities.

The goals that we are currently developing through these assessments are accurate accounting of the Public Utilities District and how service is currently provided. Billing and reconciliation of payments have been a great undertaking. Therefore, we are working diligently to credit each person who has paid their bill through their own diligence and responsibility. You will be seeing a bill shortly that will show your payments and current balance.

As any Tribal program, we are dedicated on delivering quality service for the customer base we currently have. If you are an employee, payroll deductions are a simple way of making payments and accurate accounting within Finance is provided. We will also be sending out an informative brochure of how the Public Utilities District functions and costs that are being incurred on a daily basis. If you should have additional comments and suggestions on how we can improve service to you, please give John Mosley, Environmental Director a call at (775) 574-0101 x13. If you require curbside service, a form can be filled out and a curbside bin will be provided to you expeditiously. Thank you for your patience in developing a better service to you.

Wood Cutting Permits:

The PLPT Environmental Department does not issue wood cutting permits. Please contact Della John for information regarding these permits. Also, please remember to cut and gather wood from dead trees. Cutting live trees not only impacts delicate eco systems, but also generates more smoke which effects air quality. Trees are important to this land, to help keep the river banks stable and prevent erosion. They are also important because when there were Cottonwood forests long ago, those trees kept the river cool and they were able to support the fish that are so important to our people. <u>Please do not cut green trees!</u>

which, if understood in a team environment, can reduce conflict."

If clashes at work aren't reduced, vital parts of business are affected. For example, conflict causes a distraction, which decreases productivity and is also a demotivator. Conflict also causes procrastination because your mind isn't focused on the end goal. Disagreements are taken personally; it causes resentment toward co-workers or the company as a whole.

When conflict is taken personally, it can shut down communication, cause intimidation, de-motivate, cause health issues if not dealt with, and the lack of interest to complete a mission or common goal.

However, some conflict can be healthy if you properly deal with situations to reach a proper resolution. But, this can only be done if you know how other people effectively deal with differences.

Here are five examples of conflict you might face in the workplace:

Being told what to do rather than asked. This causes tension, and employees become defensive.

Employees who have different communication styles. One employee may need specific information while the other may just need the basics. Each will shut down when there is too much (or too little) information.

Different behavioral back-up styles. For example, someone may deflect controversy for a while, but when put under too much pressure, he or she may become confrontational. Others may take offense to the back-up style, which causes conflict.

When there is not a clear vision or mission. This usually means wasted energy and money spent in a workplace.

Unclear job expectations are sure to cause conflict for the manager and the employee.

Make use of the following tips to resolve conflict at work:

Choose your battles. How important is the dispute *really*? Does it truly affect you, and is it a chronic problem? If it's a one-time incident or mild transgression, let it pass.

Expect conflict. Friction will occasionally emerge in the course of human relationships -- it's natural. Don't fear it -- rather, learn to spot the symptoms early and see opportunity in the resolution.

Use neutral language. Avoid judgmental remarks or sweeping generalizations, such as, "You never respond to my e-mails." Use calm, neutral language to describe what is bothering you. For example: "I get very frustrated when you don't return my messages because I never know if you've received important information." Be respectful and sincere, never sarcastic.

Practice preventive maintenance. Avoid retreating to the safety of withdrawal, avoidance or the simplistic view that your co-worker is a bad person. These are defense mechanisms that prevent the resolution of conflict. Instead, focus on the problem, not the person. Never attack or put the other person on the defensive.

Listen actively. Never interrupt the other party. Really listen and try to understand what the other person is saying. Let him know you understand by restating or reframing his statement or position, so he knows you have indeed heard him.

Get leverage on yourself. When disputes between you and a co-worker appear without resolution, get leverage. Ask to be held accountable. This brings your performance evaluation into the equation without taking away your responsibility for resolving the conflict. This is hard to do, but remarkable change can happen when you are held to task.

Report on Juvenile Accountability Project # 2005-JR-FX-K004

In Spring of 2005, The Pyramid Lake Tribal Council approved the submission of the 2005 Tribal Juvenile Accountability Discretionary Grant. On the resolution, it stated <u>"funding under this program would allow the Tribe to reduce criminal offenses committed by juvenile through accountability-based programs and would allow the Tribe to enhance and strengthen its juvenile justice system to ensure proper monitoring and accountability of juveniles who have committed offenses on the Pyramid Lake Indian Reservation." Tribal Resolution number PL 42-05 was voted on and passed by Council on May 18, 2005-8 in favor-0 opposed. The Grant as submitted with the blessing of the Pyramid Lake Paiute Tribal Council.</u>

The Juvenile Accountability Project # 2005-JR-FX-K004 was accepted by Chairman Harry on September 27, 2005. The grant was awarded to the Tribe, in the amount of \$297,575. The length of the grant period was October 1, 2005 though September 30, 2008. The TOTAL three year budget is as follows:

The Grant objectives were to:

Promote the Effective Administration of the Juvenile Justice of the Tribe-This

included the establishment of court that would provide efficient and expeditious process for juvenile offender, enhancing monitoring and supervision to ensure accountability of juveniles in the court system. It was also to enhance the prosecution efforts by increasing processing and relieving backlogs of the system. In order to achieve this the Tribe needed to hire court personnel to handle juvenile cases, and that is where most of the money was allocated, \$211,770 to salaries which included: Juvenile Prosecutor at 50 % of salary paid by this grant, Juvenile Defense Advocate 50% of salary paid by this grant, Juvenile Probation Officer 75% of their salary paid by this grant, and Court Clerk 75% of salary paid by this grant. This was the ratio for the duration of the grant's three year period.

Promote Education and Awareness of Tribal official into Issues of Juvenile Crimes and Delinquency-This would include tribal officials who are involved in issues where juveniles criminal and delinquency occurs. Juvenile Probation Officer worked with the Pyramid Lake High School. Juvenile Probation provided two sessions for Students, Staff, and Parents at the Pyramid Lake Jr/Sr High School. Gang Unit did a session in 2006 and a Rapper from Atlanta did a presentation at the in 2007. Court Staff were also a part of the Child Protective Team.

Establish Juvenile Court Programs on Cultural and Traditions of the Paiute

People to Foster Healthy Development-This objective may have been hard to

accomplish, as the Tribe does not have a Cultural Preservation Department. There is a Language Department, and for a short while Paiute was taught at the high school in the Dropout Prevention Room. Traditions were not a part of the program, just language.

Establish a Tribal Advisory Board on Juvenile Justice Accountability issues

Due to issues of confidentiality, this objective was met by the Court Staff being included in the Child Protective Team which meets monthly. CPT includes but is not limited to Mental Health Personnel, Court Staff, Social Services/Human Services, Local Schools Officials and Police Officers. Juvenile cases within the system may be discussed at this level. Again, due to the level of confidentiality, minutes can not be kept or made public. If community members were involved in this process, the Tribe could not ensure items discussed would remain confidential.

In conclusion, I find that the Juvenile Accountability Project grant met the majority of its objectives, mainly by establishing a separate court system. A separate court building would have been nice, but as you see from the budget, there was no money allocated for construction. The majority of the grant dollars were spent on Personnel, and Fringe Benefits. While many of our tribal grants are bases on number of possible clients served, it is usually a high estimate of actual participants of a program. The Grant was projected to provide service to 589 juveniles, there were only 61 juvenile cases recorded, but this does not take into consideration the number of contacts made under this project.

The Pyramid Lake Paiute Tribe will be returning money that was not spent at the conclusion of this grant. It was money that was not spent on salaries when the Juvenile Judge, Prosecutor and Advocate were changed from salaried employees to contractual employees, as per recommendation of IRS Julie North (?). The amount to be returned is unclear at this time, as all of the grant money was not spent.

The Court Administrator submitted her narratives, statistics and additional information to the granting agency. Receipts for her narratives are on file, she explained that when a narrative is insufficient or lacks information, the granting agency requires resubmission. Resubmission of a report was never required during the three year grant cycle.

NEWS YOU CAN USE FROM THE CONTRACT HEALTH SERVICES OFFICE

As many of you are aware, Contract Health Service (CHS) monies are decreasing each passing year. Currently the Schurz Service Unit is paying outstanding bills going back to October 1, 2007. They are utilizing the 2009 (fiscal year) first quarter funds to cover the older bills. The second quarter monies become available in January 1, 2009 so many outside providers are asking that we schedule referred patients after January 1, 2009. However, the Service Unit will have to use those monies to pay the previous outstanding bills (1st quarter).

The Indian Health Services has made it clear that they will only be covering referrals that are life and limb (priority one). If you have another level of care being referred out, you the patient will be liable for payment of any balances due to the doctor you are seeing.

This is why many of you are receiving denial letters from the Schurz Service Unit. Following is the process for appeal. As per the CHS pamphlet language:

"If payment is denied, a denial letter will be sent to you by the CHS Program. This denial letter will give the reason for denial and explain your rights to appeal the decision.

You have 30 days from the receipt of the denial letter to appeal at the local level, if you have additional information that was not already provided to the CHS Program. The local level must respond in writing within 30 days of the receipt of your appeal.

If you are not satisfied with response from the local level, you may send a letter of appeal (within 30 days) to the second level (the I.H.S. Phoenix Area Director). The Area Director's office must respond, in writing within 30 days.

Your final appeal may be made to the Director of the Indian Health Service (within 30 days of receipt of the response from the Phoenix Area Director). The decision from the office of the Director of the Indian Health Service constitutes the final administrative action; there are no further appeals."

The local level mentioned above, refers to the Schurz Service Unit. For more information or to write to your service unit, here is the contact information:

So, if you are not sure if you are eligible for Medicaid or not, contact Athena Lamebull at Pyramid Lake Health Clinic (574-1018).

If any of you have outstanding bills that you are receiving, or bills that have gone into collections related to approved referrals from this clinic, please bring them in and we match them up with the referral and send them on to Schurz Service Unit for review.

On Saturday, November 1, 2008, Jeremy W. Wright, Army Medic Specialist, son of Terry Wright, e-mailed his sister, Samantha, letting her know he was okay after Taliban mortar rounds struck the U.S. camp, killing one and seriously injuring another. Combat Outpost Lowell is a companysize American and Afghan position in Nuristan Province, near the Pakistan border. This outpost plays a remote role in the counterinsurgency efforts in Afghanistan. The camp is to disrupt the Taliban and foreign fighters on a route to Pakistani tribal areas and tying up Taliban forces far from more populated areas. It is one of the United States' most front-line positions in the war now in its eighth year. The New York Times published this encounter on November 1, 2008, A Frantic Hour With The Wounded. A Warning, a Blast, a Fight to Save an Afghan Life. The news article and photos cited the lead American Army doctor and his medical team desperately trying to save the life of an Afghan military support. An excerpt from the New York Times read, "Forty-five minutes passed. No helicopter, Jamaludin was kept alive by another Medic Specialist Jeremy W. Wright, 20, who kept him breathing by pumping an oxygen bag." Other NYT excerpts, "At about 65, the rotors could be heard in the valley. By then the medics and Captain Rodriguez were ready with Jamaludin, now bandaged and strapped onto a litter, to run across open ground." "The Taliban were waiting for them. As the medics loaded Jamaludin onto the helicopter, the mortars and fighting started again. The first round landed wide. The loudspeaker was barely audible over the roar of the Blackhawk's rotors. Incoming! Incoming! It said." "As Captain Rodriguez and the medics ran clear of the rotor blades, the helicopter shuddered, rose and lurched forward to gather speed for the run past the hills. Everyone bounded from bunker to bunker back to the aid station. An hour or so later, the call came in. The helicopter had reached the next base. Jamaludin was in surgery. He was alive." On Monday morning, Jeremy's aunties e-mailed the NYT article to other relatives and family friends. One auntie wrote, "Please pray for my nephew, my brave nephew. Jeremy is my brother Terry Wright's son." Another auntie wrote, "I am so proud of him, but at the same time, so scared for him, he makes us all proud." The Wright Family wish to pay our honor and respect to those who served in the military in times of peace and war. Our Honor and Prayers go out to our warriors who are currently serving our country during this perilous time of war. On Sunday, November 2, 2008, a blessing ceremony was held on the Terry Wright Ranch for the new family addition, Lilly Ann and her mother Samantha Wright. Submitted by: K.V. Wright



Petersen will lead conservation agency in Nevada

RENO, Nov. 12 – Bruce Petersen has been selected to serve as the state conservationist for the USDA's Natural Resources Conservation Service in Nevada, according to Sara Schmidt, regional assistant chief for the agency.

Petersen brings 22 years of experience with him to Nevada. He started as a soil conservation technician in Minnesota, working his way up to soil conservationist then district conservationist. He also worked for several years as a technician for conservation districts in Minnesota and Wisconsin. "His field experience has given him a good background in all sides of our agency," said Schmidt, "including the technical, engineering and Farm Bill program areas."

He has worked for the NRCS in Wyoming for 11 years, serving most recently as assistant state conservationist for operations. From 2001–2006, Petersen had responsibility for state-wide oversight and leadership of all Farm Bill programs. In 2006, he also assumed the duties of partnership liaison to strengthen the relationship with conservation districts and the Wyoming Association of Conservation Districts.

"My experience working for conservation districts has given me firsthand knowledge of the importance of our partnership," said Petersen. "Strengthening the relationship between NRCS and districts, and with other partners in Nevada, will be one of my highest priorities."

Petersen has a Bachelor's of Science in geography from Minnesota State University and studied Agricultural Business Management at the University of Minnesota.

He will assume his new position in mid-December.

"The Social Security Administration's Compassionate Allowances program will help streamline the disability benefits application process so that benefits are quickly provided to those who need them most."

Social Security is launching this expedited decision process with a total of 50 conditions. Over time, more diseases and conditions will be added. A list of the first 50 impairments -- 25 rare diseases and 25 cancers -- can be found at www.socialsecurity.gov/ compassionateallowances





CALL TO ORDER

Mervin Wright, Jr., Tribal Chairman, called the October 3, 2008 regular meeting of the Pyramid Lake Tribal Council to order at 7:00 p.m. in the Tribal Chambers, Nixon, Nevada.

OPENING PRAYER

There was no opening prayer.

ROLL CALL

Gina Wadsworth, Tribal Secretary, took roll call. Councilmember Janet Davis arrived at 7:04 p.m. and Councilmember Johnnie Garcia was absent from the meeting. All other Tribal Council members were present at roll call and a quorum was established for this meeting.

SPECIAL PRESENTATION - Enrollment Committee (Sylvia Davis, Judith Davis, Dora Garcia, and Cheryl Hicks): The Enrollment Committee wanted to acknowledge Dora Garcia for 31 years of service to the Pyramid Lake Paiute Tribe. On behalf of the Pyramid Lake Paiute Tribe a certificate was presented to Mrs. Garcia and a plaque from the Enrollment Committee.

CONSENT AGENDA

Tribal Council meeting minutes of September 5, 2008: Councilmember John stated on page 6 of the minutes it should read "Pyramid Lake Tribal Health Clinic." Also on page 8, the word should be "here" and not "jeer." Vice Chairman Eben said on page 8 under the Water Rate Schedule, the name should be "Randa" and not "Randy". 
ADJOURNMENT

A motion was made by Councilmember Jason Davis and seconded by Councilmember Frazier to adjourn the meeting. Votes were all in favor, motion carried.





This dramatic graph displays the global mean temperatures over time. Climate change and the greenhouse effect results in the increase of global temperatures. From 1998 to 2006 were the warmest recorded temperatures. Since 1880, the global average temperature increased 1.7°F.





Above is the common diagram of the water cycle. This is self explanatory and it displays the relationship between all water that exists within a regional watershed. Depending on the size of the watershed, water availability depends on the continual cycle of water evaporation, precipitation, runoff, and groundwater.

Increasing Demands and Climate Change Tap Limited Resources

As decision-makers and stakeholders increasing demands upon precious water resources will bring about pressures to share water amongst water users of the west. As the water supplies shrink due to climate change and other natural conditions cities, counties, states, tribes, and the federal government are obligated to seek methods to cope with limited resources and increasing demands.

One of the most critical impacts accompanying water scarcity is water guality degradation. Fresh water supplies have limited capacity to process the pollutant charges of the effluents from expanding urban, industrial and agricultural uses. When drought conditions persist, and easily recoverable groundwater reserves are depleted decreased precipitation and runoff results in a concentration of effluent in the water, which leads to an increased microbial load in waterways and drinking-water reservoirs.

One of the most significant sources of water degradation results from an increase in water temperature. The increase in water temperatures can lead to a bloom in microbial populations, which among other things can have a negative impact on human health. Additionally, the rise in water temperature can adversely affect different inhabitants of the ecosystem due to a species' sensitivity to temperature.

This presents a difficult situation for water users. Creative methods to resolve longstanding conflicts over water is needed as litigation costs are high, federal facilities are old, and laws and regulations are outdated and can not accommodate the necessary means of resolution. Stakeholders need to recognize their interests, understand their demand, and accept their
